21 having established her own consulting firm to promote and engage in
22 environmental redevelopment activities in San Francisco; and


23 WHEREAS, Sandy Sherwin has earned and maintained the esteem of her

2 now, therefore be it


3 RESOLVED, The Urban Forestry Council extends its deepest gratitude to
