ENVIRONMENTAL JUSTICE PROGRAM FUNDING RECOMMENDATIONS FOR GRANT AWARDS - 2006

The Environmental Justice (EJ) program of the Department of the Environment issued a Request for Proposals (RFP) on October 24, 2005, and received five grant proposals on January 19, 2006. The EJ program coordinated the schedule of these dates with the Department's Recycling grant program. Based on staff's review of the written grant proposals and interviews conducted with the applicants, we recommend that the Commission approve the following EJ grant awards, totaling \$212,319.

City College of San Francisco (CCSF) proposes to develop a biodiesel-alternative fuel training program for Potrero and Bayview Hunters Point residents and businesses and provide hands-on internship training to local residents. CCSF is currently operating an Advanced Transportation Technology (ATT) Center and conducted biodiesel-alternative fuel workshops last year for fleet personnel and individuals. CCSF will build on these earlier workshops and develop a 40-hour course on biodiesel and alternative fuels.

Recommended award: \$35,913

Green Depot (with Social and Environmental Entrepreneurs as fiscal sponsor) proposes to develop a biodiesel fuel supply and distribution project with the goal of displacing 250,000 gallons of petro-diesel fuel with less polluting biodiesel fuel. Green Depot will target the filling stations in the Bayview neighborhood to carry biodiesel fuel, and help educate fleet owners and truck owners and operators in the Potrero and Bayview Hunters Point communities.

Recommended award: \$72,640.

Goodwill Industries proposes to reduce diesel emissions in the Bayview area by installing a pollution reduction retrofit on diesel vehicles that will be dedicated to the Bayview Hunters Point Goodwill store, and purchasing biodiesel fuel for a truck used by Goodwill's truck driving school, which is called the Bayview Hope Trucking Academy. Goodwill also plans to use some of the funding to lease a truck training simulator, to local residents develop better truck driving skills and reduce the amount of diesel emissions generated by the BHTA training vehicle. Recommended award: \$35,000

Hunters Point Family/Girls 2000 proposes to transport and distribute fresh produce to Bayview Hunters Point community residents and local organizations, such as senior centers and day care centers, and to use a cargo vehicle fueled with biodiesel (B-100). This project is part of the Girls 2000 Healthy Lifestyles Program and will complement Girls 2000 activities in support of the Bayview Hunters Point farmers market and nutritional classes.

Recommended award: \$46,967

San Francisco Food Bank (SFFB) proposes to install several energy efficiency measures (replacing lighting, ballasts, wall switches) at its building located at 900 Pennsylvania Avenue. SFFB currently spends approximately \$8,000 on monthly utility bills for its large warehouse and offices.

Recommended award: \$21,799
